Dear Ms. Dortch:

Pursuant to Section 63.21(i) of the Commission's rules, 47 C.F.R. § 63.21(i). Sage Telecom, Inc. ("Sage"), by its attorneys, hereby notifies the Commission that it has changed its name from "U.S. Telephone Holding, Inc. d/b/a Sage Telecom" to "Sage Telecom, Inc." (together, the "Company"). Sage is authorized to provide global facilities-based and resold international telecommunications services.<sup>1</sup> While the Company's name has remained basically unchanged from a customer's perspective, the Company did not timely notify the Commission when the formal name change was originally made by amendment to the company's Articles of Incorporation in 1998. Sage regrets the omission. Sage notes, however, that Sage is appropriately registered with the Commission as a telecommunications carrier under its current name.<sup>2</sup>
