SUPPLEMENT TO JOINT INTERNATIONAL APPLICATION FOR STREAMLINED CONSENT TO TRANSFER CONTROL

This agreement was executed as follows: by Lonnie D. Pedersen, President, on behalf of Telephone Service Company; by Bruce C.

Hanson, Treasurer, on behalf of Hanson Communications, Inc., and by Bruce C. Hanson, Treasurer, on behalf of TSC Acquisition Co.

- 3) The parties clarify that the above-referenced application seeks Commission consent to a transfer of control of TSC from its current stockholders to Hanson. TSCCI will remain in existence as a subsidiary of TSC and will continue to provide service under the existing authorization. Thus, the Section 214 international authorization will remain with TSCCI.
- 4) Hanson states that, both currently and post consummation, the voting interests of the reportable owners of the transferee Hanson will be identical to the equity ownership previously reported.
