Dear Ms. Dortch:

On behalf of Consolidated Communications Holdings, Inc. ("CCH"), this Supplement provides additional information requested by Commission staff. First, CCH's Affiliates (as defined in Section 3(1) of the Communications Act ("Affiliates")) that provide telephone service are all listed on page 3 (note 2) of the Application, and are all U.S. companies. The following Affiliates are ILECs: Consolidated Communications of Texas Company, Consolidated Communications of Fort Bend Company, and Illinois Consolidated Telephone Company. The following Affiliate provides CLEC and long distance services: Consolidated Communications Network Services, Inc. The following Affiliate provides inmate payphone services: Consolidated Communications Public Services, Inc. The following Affiliate provides VoIP and long distance services: Consolidated Communications Telecom Services of Texas Company.

Second, CCH also has an Affiliate that is certified as a CLEC in Texas named Consolidated Communications Transport Company, but that Affiliate only provides transport services, and does not provide end-user telephone services. Third, approximately 75% of CCH's shares are widely distributed among numerous public minority shareholders. And finally, CCH's indirect shareholder, Richard A. Lumpkin, is a U.S. citizen.

Except as clarified through this filing, all other information in the above-referenced Application remains accurate. An original and six (6) copies of this letter are enclosed for filing with the International Bureau. A copy of this letter is also being filed in the above-referenced Wireline Competition Bureau docket via ECFS. Please date stamp the extra copy and return it in the envelope provided.
