We have received applications for authority to transfer control of SJI, LLC, Lafourche Telephone Company, LLC and SJI Networks, LLC d/b/a Latelco Long Distance to Boston Ventures Limited Partnership VII. Transferors hold domestic and international section 214 authorizations and rural radio licenses.

The following U.S.-based entities hold 10 percent or more of the equity of Boston Ventures or hold general partnership interests: Hartford Financial Services Group, Inc. (11%); State of Connecticut Retirement Plans and Trust Funds (20%); Boston Ventures Company VII, LLC (2% and general partner). The managing directors who have a 10 percent or greater interest in the general partner are U.S. citizens, with the exception of Anthony J. Bolland (**United Kingdom** citizenship), and Vikrant Raina, (**India** citizenship).
