We have received an application for consent to transfer control of NTS Communication, Inc. (NTS) to Xfone, Inc. (Xfone). NTS holds domestic and international section 214 authorizations. Abraham Keinan, Chairman of the Board of Xfone and an Israeli and British citizen, owns a 29.31 percent interest in Xfone. Campbelltown Business Ltd. (Campbelltown), a British Virgin Island private investment company, holds a 10.44 percent interest in Xfone. Guy Nissenon, a citizen of Argentina and Israel, and other members of the Nissenon family own a 20 percent interest in Campbelltown.
