Dear Sir or Madam:

USCarrier Telecom Holdings, LLC (USCTH), USCarrier Telecom, LLC (USC), and American Fiber Systems, Inc. (AFS) (collectively, Applicants) filed applications to transfer control of USCTH and USC to AFS. Applicants state that the following U.S. entities own a 10 percent or greater equity or voting interest in AFS: Sierra Ventures (41 percent), and North Atlantic Venture Fund III (13 percent). In addition, Applicants state that Lucent Venture Partners II, LLC (Lucent Venture), a U.S.-based limited liability company, owns 12 percent of the equity of AFS, and that Lucent Venture is ultimately 100 percent owned by Alcatel, a French, publicly-held telecommunications equipment and manufacturing company.
