
Dear Ms. Dortch:

Pursuant to 47 C.F.R. §63.24(e)(4), Laurel Highland Total Communications, Inc. ("Laurel Highland") hereby provides this notice to inform the Commission of the consummation of the transfer of control of Yukon-Waltz Communications, Inc. ("YWCI"), through the change of control of YWCI's parent company, Yukon-Waltz Telephone Company ("YWTC"). The change in control arises from the purchase by Laurel Highland of all outstanding shares of YWTC. The consummation occurred on December 1, 2008. YWCI's international Section 214 authority was granted under File No. ITC-214-20080307-00140. The transfer of control of YWCI was approved under File No. ITC-T/C-20080409-00190.

Laurel Highland notes that the domestic transfer of control application involving YWTC and YWCI as noted in WC Docket No. 08-37 was also consummated on December 1, 2008.
