In accordance with the request of International Bureau staff member, Sumita Mukhoty, for supplemental information in the above captioned matter we hereby amend the application in the above captioned matter as follows:

In accordance with Section 63.25 of the Commission's rules, IBFA Acquisition Company, LLC ("IBFA") requests special temporary authority to continue providing service to customers while the Commission processes the transfer of control application for the international section 214 authority in File Number ITC-T/C-20080507-00221 in which IBFA is requesting authority for a transfer of control to Telaya Acquisitions, Inc.

IBFA filed an application in File Number ITC-T/C-20080721-00342 requesting approval of a transfer of control of membership interest from Kathleen Grabowski to James Grabowski. Special temporary authority is needed because the underlying transfer was completed without prior Commission approval. IBFA did not request prior consent from the Commission due to an interpretation of the rules which differs from the FCC staff. IBFA's original members included Casimir Wojciechowski with 50% membership interest and James and Kathleen Grabowski (collectively, "the parties"), a husband and wife, with 25% membership interest each. Shortly after the company was formed it became apparent that Kathleen Grabowski would not be actively participating in the business and her membership interests were transferred to her husband, James Grabowski. This transaction occurred 1/11/2008. The parties are now aware of their responsibilities and commit themselves to seeking prior consent before any future transfer of control of 214 authority.
