- 1. <u>Citizenship of Gordon Holmes</u>: Gordon Holmes, one of eight managing members of QCP GP Investors II LLC ("QCP")(listed in footnote 3 of the Public Notice, DA 08-2063), is an Irish national, and holder of a U.S. green card. His application for United States citizenship is pending. Mr. Holmes will not have a controlling position in Hargray-Smart City Acquisition Co., LLC ("Hargray-Smart City") or QCP, under any analysis, for the following reasons:
- Mr. Holmes will not be an officer or director or a direct equity holder of Hargray-Smart City.
- QCP will not participate in day-to-day management of Hargray-Smart City.

- Mr. Holmes owns less than 10% of QCP.
- All investment decisions made by QCP with respect to Hargray-Smart City will be made by
  an Investment Committee, comprised of seven managing members of QCP, one of whom is
  Mr. Holmes. Each member of the Investment Committee has one vote. Accordingly, Mr.
  Holmes would never be in a position to control a decision made by the Investment
  Committee. Nor would Mr. Holmes be in a position to control QCP by virtue of his equity
  position in QCP.
