The Department of Justice ("DOJ"), including the Federal Bureau of Investigation ("FBI"), with the concurrence of the Department of Homeland Security ("DHS") (collectively, the "Agencies"), officially withdraws its request to defer action on the above-referenced application to transfer control of international section 214 authorizations held by Smart City Telecommunications LLC (SCT), and of domestic section 214 authority held by SCT and Smart City Solutions, LLC, from their sole member, Smart City Finance LLC to Hargray-Smart City Acquisition Co. LLC. Based on the information provided to the Agencies by the Applicants and analysis by the Agencies of potential national security, law enforcement and public safety issues, the Agencies hereby notify the Commission that they have no objection to the application.
