pro forma transfer of control of Pacifictel International, Inc.

Dear Secretary Dortch:

Pacifictel International, Inc. (“Pacifictel International”), by its attorneys hereby supplements its earlier filing of December 3, 2008 notifying the Commission that, on October 31, 2008, Fondo De Solidaridad (“Fondo”), the 100% indirect owner of Pacifictel International, consummated an internal restructuring that resulted in a *pro forma* transfer of control of the international section 214 license held by Pacifictel International.¹ Diagrams depicting the relationships between the affected corporate entities both before and after the restructuring are provided in Exhibit A hereto.

As a result of this restructuring, Fondo merged two subsidiary telecommunications entities, Pacifictel, S.A. and Andinatel, S.A., into the newly formed-entity, Corporacion Nacional de Telecomunicaciones CNT, S.A. (“CNT, S.A.”). Because 100% ultimate ownership remains in Fondo, this transfer of control was presumptively *pro forma*, and thus requires only this notification filing, not prior Commission approval because it involved an “assignment or transfer from a corporation to a wholly owned direct or indirect subsidiary thereof or vice versa”²

Consistent with the requirements of section 63.24(f)(2) of the Commission’s rules, which requires that the content of every notification of a *pro forma* transaction include the

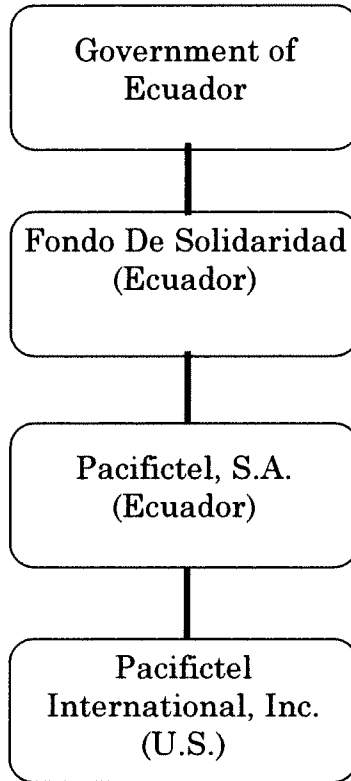
