This letter responds to the request for further information, presented yesterday by the staff of the Commission's International Bureau, concerning the above-referenced amendments to the transfer of control applications of Caribbean Crossings Ltd. and Trinity Communications Ltd. (collectively, the "Companies"). Specifically, the staff has requested information required under Section 63.18(h) of the Commission's rules, 47 C.F.R. § 63.18(h), regarding the Trustee who will control 5,000,000 shares of the common stock of the Companies' parent company, Cable Bahamas Ltd. ("CBL") currently held by Columbus Communications Ltd., under the terms of a newly executed Trust Declaration. Section 63.18 of the Commission's rules requires information regarding the name, address, citizenship and principal businesses of any person or entity that directly or indirectly owns at least ten percent of the equity of an applicant, and the percentage of equity owned by each of those entities (to the nearest one percent). The rule section also requires the applicant to identify any interlocking directorates with a foreign carrier.

The Trustee created under the terms of the Trust Declaration is Dr. Keva Bethel, a retired professor, is a citizen of the Commonwealth of The Bahamas. Dr. Bethel's address is P. O. Box N-1232, Nassau Bahamas. The 5,000,000 shares of CBL common stock held by Dr. Bethel pursuant to the Trust Declaration will represent 26.74%% of CBL's outstanding capital shares, following the closing of the transaction. As a shareholder, Dr. Bethel will also have a 26.74%%
