Dear Ms. Dortch:

On behalf of Integra Telecom Holdings, Inc. ("Integra Holdings"), Eschelon Telecom, Inc., Electric Lightwave, LLC, and other subsidiaries of Integra Holdings set forth in the above-referenced application (collectively, the "Applicants"), this supplement is filed pursuant to Section 1.65 of the Commission's Rules to supplement the record with respect to the above-referenced applications in connection with a request from Commission staff in the Wireline Competition Bureau.

The following information is provided at the request of Commission staff:

- (1) The Applicants' ultimate parent, Integra Telecom, Inc. is incorporated in the state of Oregon.
- (2) The Applicants understand and agree that within thirty (30) days of the completion of the Restructuring described in the joint applications captioned above, the Applicants will file a supplement setting forth the then-current equity ownership percentages held by each ten (10) percent or greater holder of interests in Integra Telecom, Inc.
- (3) With respect to transferee Goldman, Sachs & Co's interest in Global Tel\*Link, a prison and public payphone provider, and any geographic overlap between service areas of Global Tel\*Link and Scott-Rice Telephone Company ("Scott-Rice"), Integra Telecom, Inc.'s incumbent local exchange carrier ("ILEC") subsidiary, Applicants and Goldman have reviewed the applicable service areas and have determined that Global Tel\*Link does not currently provide prison or payphone services in the telephone exchanges served by Scott-Rice, *i.e.* Prior Lake, Webster, and the New Market exchanges, all in rural markets in Minnesota.

- (4) With respect to four (4) business customers in Washington state discussed in the joint applications captioned above as transitioning services to another provider (*see*, *e.g.*, page 10 of the joint applications), the Applicants update the information set forth in the joint applications to state that subsidiary Advanced TelCom, Inc. ("ATI") has received notification from all customers that they have transitioned to an alternate carrier (*i.e.*, the underlying carrier from whom ATI was reselling services). As such, they have transitioned from ATI as a service provider and are now taking service from the underlying incumbent local exchange carrier.
- (5) Applicants wish to take this opportunity to correct a typographical error. Specifically, on Schedule II to the Joint Applications (Integra Telecom, Inc. Investors Before and After Restructuring Transaction), the post-Restructuring numbers for "Other Minority Investors" should read "28.84%" rather than 31.90%.
