("Lexcom") (together, the "Applicants") hereby submit additional clarification concerning the Applicants and the markets at issue in the abovereferenced domestic Section 214 transfer of control application.

- 1. Transferor Lexcom, Inc. is a holding company that does not provide telecommunications services in its own right.
- 2. The Lexcom subsidiaries that hold Section 214 authority are all direct or indirect whollyowned subsidiaries of Lexcom Inc. Lexcom Telephone Company ("Lexcom Telco") is a wholly owned subsidiary of Lexcom, Inc., and Lexcom Long Distance, LLC, in turn, is a wholly-owned subsidiary of Lexcom Telco.

- 3. Windstream's incumbent local exchange carrier and interexchange carrier subsidiaries in North Carolina are all direct or indirect wholly-owned subsidiaries of Windstream Corporation.
- 4. In the Lexington exchange, Windstream and Lexcom face direct competition from Time Warner Cable Information Services and a number of wireless carriers, including AT&T Wireless, Verizon Wireless, Sprint/Nextel, and T-Mobile. Applicants also face potential competition from adjacent ILEC operators, including AT&T and Randolph Telephone.
