Access Media 3, Inc. ("AM3"), by and through undersigned counsel and pursuant to Commission Rule 1.65, 47 C.F.R. §1.65, hereby files this supplement to update the above-captioned application ("Application") and to advise the International Bureau of certain *pro forma* changes to AM3's corporate structure and proposed post-closing ownership.

AM3 is authorized to provide international resold and facilities-based services pursuant to authority granted by the Commission in File No. ITC-214-20070418-00149. As set forth in greater detail in the above captioned application, AM3 seeks authority to complete certain transactions related to the ultimate ownership of AM3 (the "Investment Transactions").

In addition to the Investment Transactions, AM3 proposes to complete two acquisitions as follows:

AM3 proposes to acquire certain U.S. domestic operating assets, including customers, from MCS Master Communications Systems, Inc. d/b/a Avvid Technologies ("MCS" - FRN # 0019271535) a Minnesota Corporation located at 7802 Telegraph Road #120, Bloomington, Minnesota 55438. MCS is engaged in the business of selling, installing and providing certain services to residential multi-dwelling units ("MDU") in apartments and condominiums, nursing homes, assisted living facilities, colleges, universities and other similar multi-dwelling buildings located in Minnesota. In addition to a variety of unregulated services, MCS provides to its residential MDU customer base certain domestic wireline point to point dedicated services. AM3 and MCS have entered into an Asset Purchase Agreement whereby AM3 will purchase those residential MDU operations. The MCS transaction will not affect the ownership of AM3.

AM3 proposes to acquire certain U.S. domestic operating assets, including customers from onShore Networks, LLC ("onShore" – FRN # 0018093435), an Illinois limited liability company located at 1407 West Chicago Avenue, Chicago, Illinois 60642. AM3 will acquire onShore from onShore's corporate parent, onShore Networks of Illinois, L.L.C., an Illinois limited liability company ("onShore-Illinois"). Like MCS, onShore is engaged in the business of providing services to residential MDU properties, including certain domestic wireline point to point dedicated services. onShore's operations are located in the State of Illinois.

The onShore transaction will result in two pro forma changes to AM3's corporation structure and ownership. First, as set out in the Application, through the Investor Transactions, AM3 proposes to create a new holding company, AM3 Holding Corp. ("AM3 Holding"). In connection with the onShore transaction, AM3 will create an additional holding company, AM3 Pinnacle Corporation ("Pinnacle" (FRN # 0019404722). Pinnacle is a Delaware corporation. Pinnacle will own all of the stock of AM3 Holding and will, in turn, be owned by the various investors previously disclosed in the Application. Second, in return for ownership of onShore, onShore-Illinois will receive an eight percent (8%) ownership interest in Pinnacle, which will, in turn, slightly reduce the ownership interests of the investors. Revised ownership information reflecting those updated percentages is provided below and in the chart contained in Exhibit A hereto:


