**APPLICATION FOR CONSENT TO TRANSFER
INTERNATIONAL AUTHORITY PURSUANT TO SECTION 214 OF THE
COMMUNICATIONS ACT OF 1934, AS AMENDED**

Woodland Holdings, Corp. ("Woodland"), hereby submits the following supplemental information at the request of the Commission staff and in connection with the above-referenced application (the "Application").

Woodland is waiting for application approval to purchase 100% of the stock and assets of T2 Communications, LLC (T2). Woodland has a pending purchase agreement in place to acquire T2 with a draft date of March 2009. Upon transfer of control, T2 will be a wholly owned subsidiary of Woodland. Woodland does not have a 214 license today in its name and once it completes the transaction to purchase T2, T2 will continue to provide the same services as it presently does but as a subsidiary of Woodland. Woodland will not be providing T2 services.

Woodland, incorporated in the state of Delaware with offices at 301 Hoover Blvd, Holland MI, 49423 telephone number 616-638-9535, is owned 100% by Cornerworld Corporation. Cornerworld, a publicly traded company is incorporated in the state of Nevada with its offices at 12404 Park Central Drive, Suite 400, Dallas, TX 75251 Telephone 214-224-1081. Cornerworld Corporation has two shareholders with at least ten percent interest: Mr. Scott Beck owns 15% and Mr. Ned Timmer owns 33% of Cornerworld Corporation. Each Cornerworld stock is entitled to one vote and no shareholders have preferred or other stock with voting rights beyond one vote per one share. Both Mr. Beck and Mr. Timmer are individuals and US citizens and both with a mailing address at 301 Hoover Blvd, First Floor, Holland, MI 49423. Mr. Beck, Mr.


Timmer nor other shareholders of Cornerworld own any other telecom companies. No other person or entity directly or indirectly owns at least 10% of Woodland Holdings or Cornerworld Corporation. .

T2 Communications, LLC is owned 100% by Mr. Timmer. T2 Communications will not hold ownership interest in Woodland or Cornerworld.

Conclusion

For the foregoing reasons, the Applicant respectfully submits that grant of this Application by the Commission would serve the public interest, convenience and necessity.
