



Answer to Question 13:

This filing, pursuant to Section 63.24(f) of the Commission's rules, serves as notification of the *pro forma* transfer of control of the international 214 authorization held by OnStar, LLC (the "Licensee") from General Motors LLC (the "Transferor") to General Motors Holdings LLC (the "Transferee"), a holding company with the same ultimate ownership as the Transferor.

On November 2, 2009, the Transferor transferred its equity interests in the Licensee to the Transferee, which resulted in a *pro forma* transfer of control of the Licensee's international 214 authorization. In addition, as part of this transaction, General Motors Holding Company, the ultimate parent company of the Licensee, Transferor, and the Transferee, was re-named General Motors Company. This *pro forma* transfer of control serves the public interest because it allows for the efficient post-bankruptcy reorganization of General Motors and ensures that the FCC licenses continue to be put to productive use by the Licensee.
