Pursuant to Staff's request, Applicants hereby supplement the pending Application in the above-referenced proceeding to provide additional information about ownership and service areas.

Ownership

RCN Corporation currently controls the following wholly-owned operating subsidiaries: RCN Telecom Services, Inc., RCN Telecom Services (Lehigh) LLC, RCN-BecoCom, Inc., RCN BecoCom LLC, RCN Telecom Services of Illinois, LLC, RCN New York Communications, LLC, Starpower Communications, LLC, RCN Telecom Services of Philadelphia, Inc., RCN Telecom Services of Philadelphia LLC, RCN Telecom Services of New York, LP, RCN Telecom Services of Massachusetts, Inc., RCN Telecom Services of Washington, D.C., Inc., and NEON Optica, Inc. As stated on page 11 of the Application, no entity holds a 10% or greater direct or indirect interest in RCN Corporation, and there are, therefore, no reportable owners.

No investor in ABRY Partners VI, L.P. or ABRY Senior Equity III, L.P. will hold a 10% or greater indirect ownership stake in either Yankee Cable Acquisition, LLC or Yankee Metro Parent, Inc., and there are, therefore, no reportable owners of ABRY Partners VI, L.P. or ABRY Senior Equity III, L.P. Royce Yudkoff ultimately controls the general partners of each of ABRY Partners VI, L.P. and ABRY Senior Equity III, L.P.

ABRY Partners VI, L.P. will have majority ownership and sole voting rights in Yankee Cable Acquisition, LLC, and no other investor has a 10% or greater ownership stake in Yankee Cable Acquisition, LLC. ABRY Partners VI, L.P. and ABRY Senior Equity III, L.P., together will have majority ownership of Yankee Metro Parent, Inc. ABRY Partners VI, L.P. will have sole voting rights in Yankee Metro Parent, Inc., and no other investor has a 10% or greater ownership stake in Yankee Metro Parent, Inc. Applicants

RCN Telecom Services of Philadelphia, Inc. currently provides competitive intrastate telecommunications services in Pennsylvania. Starpower Communications, LLC currently provides competitive intrastate telecommunications services in the District of Columbia, Maryland, and Virginia. RCN New York Communications, LLC currently provides competitive intrastate telecommunications services in Connecticut, Delaware, the District of Columbia, Illinois, Massachusetts, Maine, New Hampshire, New Jersey, New York, Pennsylvania, Rhode Island, Vermont, and Virginia.
