Mr. Leslie has been the Chief Operating Officer of ITS since 1996 and its President and Chief Executive Officer since 2007. He has no ownership interests in any unrelated providers of telecommunications services.

No other entity will own or control, directly or indirectly, ten percent (10.0%) or more of the equity or voting rights of Postco or ITS after the proposed transaction.

Answer to Question 12

Neither Postco nor ITS nor any of their subsidiaries or affiliates has any interlocking directorates with a foreign carrier.

Answer to Question 13

Mr. Leslie, who has been the Chief Operating Officer of ITS since 1996 and its President and Chief Executive Officer since 2007, is purchasing 100 percent of the issued and outstanding stock of Postco from the Trust. The transaction is part of the distribution of the assets of Robert M. Post, Jr., the former owner of Postco and its subsidiary ITS, who died in 2007. At the completion of the transaction, Mr. Leslie will own 100 percent of the issued and outstanding Postco stock, and will thereby control Postco's wholly-owned subsidiary ITS and the International Section 214 Authorization of ITS for Global Resale.
