Re: WC Docket No. 10-106 – Application of MobilePro Corporation, American Fiber Network, Inc. and New Earthshell Corporation to Complete the Transfer of control of American Fiber Network, Inc.

Dear Ms. Dortch:

On behalf of MobilePro Corporation (“MobilePro”), American Fiber Network, Inc. (“AFN”), and New Earthshell Corporation (“NEC”), we hereby submit this supplement to the above-referenced application. Specifically, we are providing the following requested information.

1) Yorkville Advisors, LLC (“Yorkville”) is the Investment Manager for YA Global Investments, L.P. (“YA Global”) pursuant to an August 1, 2007 Investment Management Agreement between Yorkville and YA Global. As the Investment Manager, Yorkville is contractually authorized to act on behalf of YA Global and make all investment decisions for YA Global. Thus, Yorkville exercises direct *de facto* control of YA Global and indirect *de facto* control of New Earthshell Corporation (“NEC”). Yorkville is the only entity that has this *de facto* control. Upon consummation of the proposed transaction, Yorkville would have indirect *de facto* control of American Fiber Network, Inc. (“AFN”). The U.S. individuals identified below have equal rights to make decisions for (*i.e.*, exercise *de facto* control of) Yorkville and hold the stated ownership interests in Yorkville.

Troy Rillo: 0%
Ed Schinik: 0%

Yorkville has a 0% equity interest in YA Global.

2) Yorkville Advisors GP, LLC (“Yorkville Advisors GP”) is the General Partner of YA Global. Yorkville Advisors GP has a less than 1% equity interest in YA Global. The U.S. individuals identified below hold the stated ownership interest in Yorkville Advisors GP.
