COMBINED/JOINT INTERNATIONAL AND DOMESTIC APPLICATION FOR TRANSFER OF CONTROL

NOW COMES Billing Services of America, Inc., a Nevada Company, ("BSAI" or "Company"), Kenneth Batten, Larry Correia ("Transferor") and James A. Holmquist as Trustee of the James A. Holmquist Revocable Trust, under Agreement dated January 18, 2002 ("Transferee"), (collectively referred to as the "Applicants") and hereby request pursuant to Section 214 of the Communications Act of 1934, as amended (the "Act"), and sections 63.04 and 63.24 of the Commission's rules, Commission approval to transfer control of BSAI to

Transferee. BSAI holds authority to provide domestic and international telecommunications service pursuant to Section 214 of the Act.¹

The Applicants have agreed to a transaction whereby the Transferee will acquire 100 percent of the shares in the Company from the Transferor. The transaction provides for the existing stockholder of Company to receive consideration in the form of cash. After regulatory approval, the shareholder shall sell his interest to the Buyer, and the Buyer shall purchase such shares from the shareholder in exchange for the foregoing consideration.

The transfer of shares of the Shareholders to Transferee is in the public interest. The proposed Transaction does not involve the transfer of any operating authority. Although BSAI's ownership will change, its operations and customers likewise will not be affected by the Transaction. Immediately following the closing, BSAI will continue to offer its customers the same services at the same rates, terms and conditions as at present pursuant to existing authorizations, tariffs, contracts, and published rates and charges. The only change will be that BSAI will be owned by Transferee. The Transaction is not expected to result in any discontinuance of service for any customer.

I. INFORMATION REQUIRED BY SECTION 63.24

This Application seeks authority to transfer control of BSAI, which holds authority pursuant to Section 214 of the Act to provide domestic interstate and international telecommunications service, to Transferee. Section 63.24(e)(2) of the Commission's rules requires that an application for a substantial transfer of control of a carrier holding international Section 214 authority include the following information, as described in Section 63.18:

This Application seeks Commission consent to transfer control of BSAI, which hold authority to provide domestic and international services pursuant to Section 214 of the Act. Pursuant to Section 63.04(b) of the Commission's rules, the parties submit the following information in support of this Application in response to items 6 through 12 of Section 63.04(a):

- As set forth above, this Application seeks Commission consent to transfer control of BSAI to Transferee. As a result of the transfer, BSAI will continue to operate and provide service pursuant to the authority of BSAI, the transfer of control of which is being sought through this Application.
- 7) BSAI is authorized as a reseller of interexchange services in Indiana, Massachusetts, Michigan, New Jersey, New York, Ohio, Pennsylvania, Texas, Virginia and Wyoming. Transferors are individuals and therefore do not currently provide telecommunications services. Transferee is an individual and therefore does not currently provide telecommunications services.
- 8) This Application qualifies for streamlined processing under Section 63.03(b)(1) because the transferee is not a telecommunications service provider.
- 9) A Section 63.24 international transfer of control application is being filed concurrently with the application.
- 10) The Parties are not requesting special consideration because one or more of the Parties is facing imminent business failure.
- 11) No waiver requests are being filed in conjunction with the transaction.
- 12) As discussed above, grant of this Application will strengthen BSAI as the post-transaction company will continue to be a competitor in the marketplace for interstate and international telecommunications services. The customers of BSAI will benefit from Transferee's resources and assets, which will help ensure continuity of service and enhance the ability of BSAI to offer a broader range of innovative products and services to customers. Grant of this Application will promote competition in the domestic interexchange and international telecommunications markets and will serve the public interest.

III. CONCLUSION

Based on the foregoing, Applicants respectfully request that the Commission consent to the transfer of control of BSAI to Transferee.


