**SUPPLEMENTAL INFORMATION IN SUPPORT OF  
JOINT APPLICATION**

In support of their Joint Application requesting authority to transfer control of the domestic and international § 214 authorizations held by CCTC’s subsidiary companies to Great Lakes Comnet, Inc. (GLC), Clinton County Telephone Company (CCTC), Westphalia Telephone Company (WTC), Westphalia Broadband, Inc. (WBI), Westphalia Communications Incorporated (WCI) and GLC (collectively, “Joint Applicants”) hereby respectfully supplement their Joint Application as provided herein.

**A. Services Provided**

As requested by the Wireline Competition Bureau, in the table that follows, the Joint Applicants provide more detailed information regarding the types of services provided by the entities discussed in their Joint Application, as well as the geographic locations in which such services are provided. Attachment A contains an exchange map to assist in locating any exchange areas referenced in the table. Any exchange area referenced in the table below wherein there is any overlap between the transferor and transferee entities is identified in yellow on Attachment A. Other referenced exchanges are identified in red.

## **B. Population of Exchanges in which Transferor and Transferee Entities Overlap**

As requested by the Wireline Competition Bureau, the Joint Applicants provide population information regarding the exchanges in which the transferor and transferee entities have geographic overlap. As indicated in the table above, the areas of geographic overlap are the Westphalia, Dewitt, and St. Johns exchanges.

For the Joint Applicants to provide population data at the exchange level is difficult, given that exchange boundaries overlap municipal (and even county) boundaries, resulting in some exchanges encompassing only portions of a municipality. Nevertheless, the Joint Applicants can advise that the Westphalia exchange, wherein WTC is the ILEC, is generally rural, with sparse population. The Westphalia exchange encompasses the Village of Westphalia (population 813 in 2009), Westphalia Township (population 2,240 in 2009), Dallas Township (population 2,308 in 2009), Riley Township (population 1,778 in 2009), Eagle Township (population 2,302 in 2009), Portland Township (population 2,531 in 2009) and Lyons Township (population 3,525 in 2009).<sup>2</sup> Because some of these municipalities lie only partially within the Westphalia exchange, the total of the above population numbers would exceed the population of the Westphalia exchange. Nevertheless, the populations of the listed municipalities are indicative of the rural nature of the Westphalia exchange. WTC has approximately 1,000 customers in the Westphalia exchange.

The St. Johns exchange, wherein WBI is a CLEC (and through which GLC's fiber network passes) encompasses the City of St. Johns (population 7,300 in 2009), Bengal Township (population 1,237 in 2009), Bingham Township (population 2,477 in 2009), Duplain Township (population 2,283 in 2009), Essex Township (population 1,820 in 2009), Greenbush Township

(population 2,094 in 2009), Olive Township (population 2,294 in 2009), Ovid Township (population 3,373 in 2009), Riley Township (population 1,778 in 2009), and Victor Township (population 3,185 in 2009). The DeWitt exchange, wherein WBI is a CLEC (and through which GLC's fiber network passes) encompasses the City of DeWitt (population 4,421 in 2009), DeWitt Township (population 13,100 in 2009), Olive Township (population 2,294 in 2009), Riley Township (population 1,778 in 2009), and Watertown Township (population 1,778 in 2009).<sup>3</sup> As with the Westphalia exchange, because some of these municipalities lie only partially within the DeWitt and St. Johns exchanges, the total of the above population numbers would exceed the population of both exchanges. In any event, their population numbers likewise indicate that the St. Johns and Dewitt exchanges are generally rural.

### **C. Additional Information Regarding Competition**

#### **1. Generally**

The Wireline Competition Bureau has also inquired whether competition exists in the areas in which the Joint Applicants' service areas overlap (i.e., the Westphalia, St. Johns, and Dewitt exchanges). As an initial matter, the Joint Applicants do not anticipate that their proposed merger itself will have any adverse effect on competition. GLC's presence in the Westphalia exchange, wherein WTC is the ILEC, is limited to providing tandem switching and transport services to other carriers as set forth in the table above, including to WTC. GLC does not provide any service to the public in the Westphalia exchange. Likewise, in the DeWitt and St. Johns exchanges in which WBI operates as a CLEC, GLC has fiber facilities that pass through those exchanges, but it does not provide any services to the general public, or in competition with WBI. As noted in the above table, GLC provides its toll services to WCI for resale by WCI to WCI's own end users, and thus GLC is not in competition with WCI. Because

GLC does not compete with WTC, WBI, or WCI in any area, nor even provide the same type of services, the Joint Applicants do not anticipate that the proposed merger will adversely affect competition. Following the proposed merger, GLC would operate as an independent provider of tandem, transport, and other services, just as it does currently.

Comlink, GLC's wholly-owned subsidiary, does not have any customers in the Westphalia exchange wherein WTC is the ILEC, nor does Comlink have any customers in the Fowler (a/k/a the Fowler-Pewamo exchange), DeWitt, or St. Johns exchanges wherein WBI operates as a CLEC. In the exchanges that are adjacent to the Fowler, DeWitt, and St. Johns exchanges, Comlink provides only point-to-point private line service in two such exchanges (Portland and Lansing).

As a result of the foregoing, the three subsidiaries of CCTC—WBI, WTC and WCI—are not in competition with GLC or Comlink. After the merger transaction described in the Joint Application, WBI, WTC, and WCI will continue to provide services to their respective end users just as they did before the merger. GLC and Comlink will likewise continue to provide respective services as they did before the merger. As a result, no provider will exit the market as a consequence of the merger.

## **2. DeWitt and St. Johns Exchanges**

Because the Joint Applicants do not have access to other carriers' customer and business information, they are unable to comprehensively assess the amount of competition in the exchanges in which the transferor and transferee entities overlap. The DeWitt and St. Johns exchanges are served by a large ILEC, Frontier North, Inc. (formerly Verizon North, Inc.), which, on information or belief, provides a full array of basic and advanced telecommunication services, toll services, and tandem and transport services of the type provided by the Joint Applicants.



As reflected in Attachment B, which consists of a list of licensed telephone companies compiled by the Michigan Public Service Commission (MPSC), dozens of carriers are licensed to provide local exchange service in all or part of Clinton County, which encompasses the DeWitt and St. Johns exchanges in which WBI operates as a CLEC. A non-exhaustive review of the online tariff filings for these companies reveals that the following carriers' tariffs offer competitive local exchange service in the DeWitt and St. Johns exchanges:

### **3. Westphalia Exchange**

In the Westphalia exchange, competition with WTC is mainly from cellular providers, which the Joint Applicants do not expect will change as a result of the proposed merger. As noted previously, Comlink does not provide any service to the public in the Westphalia exchange, and thus no competitor of local exchange service will be eliminated by the proposed merger. The Westphalia exchange is rural, and as the Commission has recently observed, rural exchanges are less likely to experience competition because of the high costs of serving consumers and the relatively low potential revenues from less dense areas. March 18, 2011 Memorandum Opinion and Order, WC Docket No. 10-110 (rel'd March 18, 2011), ¶ 19. The Commission should conclude that no adverse effect on competition will occur in the rural Westphalia exchange as a result of the proposed merger, just as it did in the referenced order in WC Docket No. 10-110.

The Westphalia exchange is the location of GLC's tandem switch, from which GLC provides tandem switching services to its ILEC, CLEC, interexchange carrier, and other customers. GLC provides its long-haul Internet connectivity, video and other transport, toll resale, and SS7 services from other office locations, and not the Westphalia exchange; such services are provided in the Westphalia exchange only to the extent that WTC is a customer of GLC. GLC faces full competition for all these services. Tandem switching and transport service is provided throughout Michigan by AT&T Michigan, Frontier North, Inc., and Frontier Midstates, Inc., as well as by Neutral Tandem. GLC would continue to provide its tandem switching, transport, and other services in competition with these other companies after the proposed merger.

The merger will also not have any adverse effect on the toll market. The following carriers offer domestic and international toll services in the three exchanges in which the transferor and transferee entities overlap:

- AT&T
- Frontier Communications
- Global Crossing Telecom
- MCI
- Norlight
- Qwest Communications
- Sprint
- Focal Communications
- Worldcom
- XO Communications

Finally, per the request of the Wireless Competition Bureau, the Joint Applicants hereby verify that neither GLC, nor any subsidiary or owner company, is the ILEC in any exchange that is adjacent to the Westphalia exchange in which WTC is the ILEC.

**D. Public Interest, Convenience and Necessity**

As discussed in the Joint Application, the transaction described herein will serve the public interest, convenience and necessity. Since 2001, GLC has used state-of-art technology to meet its carrier customers' sophisticated communications needs in 80 Michigan counties. GLC is a successful, rapidly-growing, provider of broadband and switching infrastructure. GLC was organized as a for-profit Michigan based corporation in 1996. When the company became operational in 2001, it had 5 employees and no fiber optic cable. GLC has expanded its operations every year since 2001. As of March 2011, GLC has 31 employees, and has more than 1,800 fiber miles stretched throughout Michigan and the Midwest, with an additional 2,000 miles under construction.

GLC is devoted to increasing speed and reliability for its ILEC, CLEC, interexchange carrier, and data customers, and to the expansion of broadband throughout Michigan. As a result of GLC's future expansion, GLC's telecommunications carriers and their customers will benefit from next-generation voice, video, SS7 and data service technologies. As noted above, GLC also owns and operates its independent tandem switch, which connects more than 150 carriers, and has a vertically integrated system of voice, SS7, data and transport that efficiently facilitates voice and data communications.

CCTC's three subsidiary companies would continue to provide services to their customers without change or interruption, and the transfer of control would be transparent to customers. CCTC's subsidiaries would be able to draw from a new source of expertise and financial resources. The three CCTC subsidiaries have a combined total of 16 employees, and thus having GLC as its parent company would roughly triple the amount of available human resources. With the support of GLC as its parent company, CCTC and its subsidiaries would continue to provide high quality telecommunications services, and will have more financial, managerial, and technical resources available to them as a result. The transaction will have no adverse impact on customers, and the transaction will not trigger any rate increases. The transaction will not lead to the concentration of any market share, nor will it present any anti-competitive issues, or eliminate a competitor, because CCTC's subsidiaries will continue to provide service as they did before the proposed merger.

**E. Additional Information Regarding Owners of GLC**

At the request of the International Bureau, Great Lakes Comnet, Inc. provides additional information regarding its owners.

First, as stated in the Joint Application, Ace Telephone Company of Michigan, Inc. (ATCM) holds a 28% equity interest in GLC. ATCM, in turn, is owned 100% by Ace Telephone Association (ATA), a Minnesota member-owned cooperative. No person or entity owns a 10% or greater equity interest in ATA.

Second, as stated in the Joint Application, Bloomingdale Communications, Inc. (BCI) holds a 12% equity interest in GLC. BCI, in turn, is the wholly-owned subsidiary of Bloomingdale Telephone Company (BTC). Under the ownership attribution rules set forth in 47 CFR 63.18(h), BTC is deemed to own 12% of GLC. Regarding the owners of BTC, only one person or entity owns more than a 10% equity interest in BTC (that owner owns 21%). Under 47 CFR 63.18(h), a 21% ownership interest in BTC amounts to a 2.52% (21% of 12%) equity interest in GLC.

As a result of the foregoing, no entity or individual holds a direct or indirect 10% or greater equity or voting interest in GLC except for those discussed in the Joint Application.

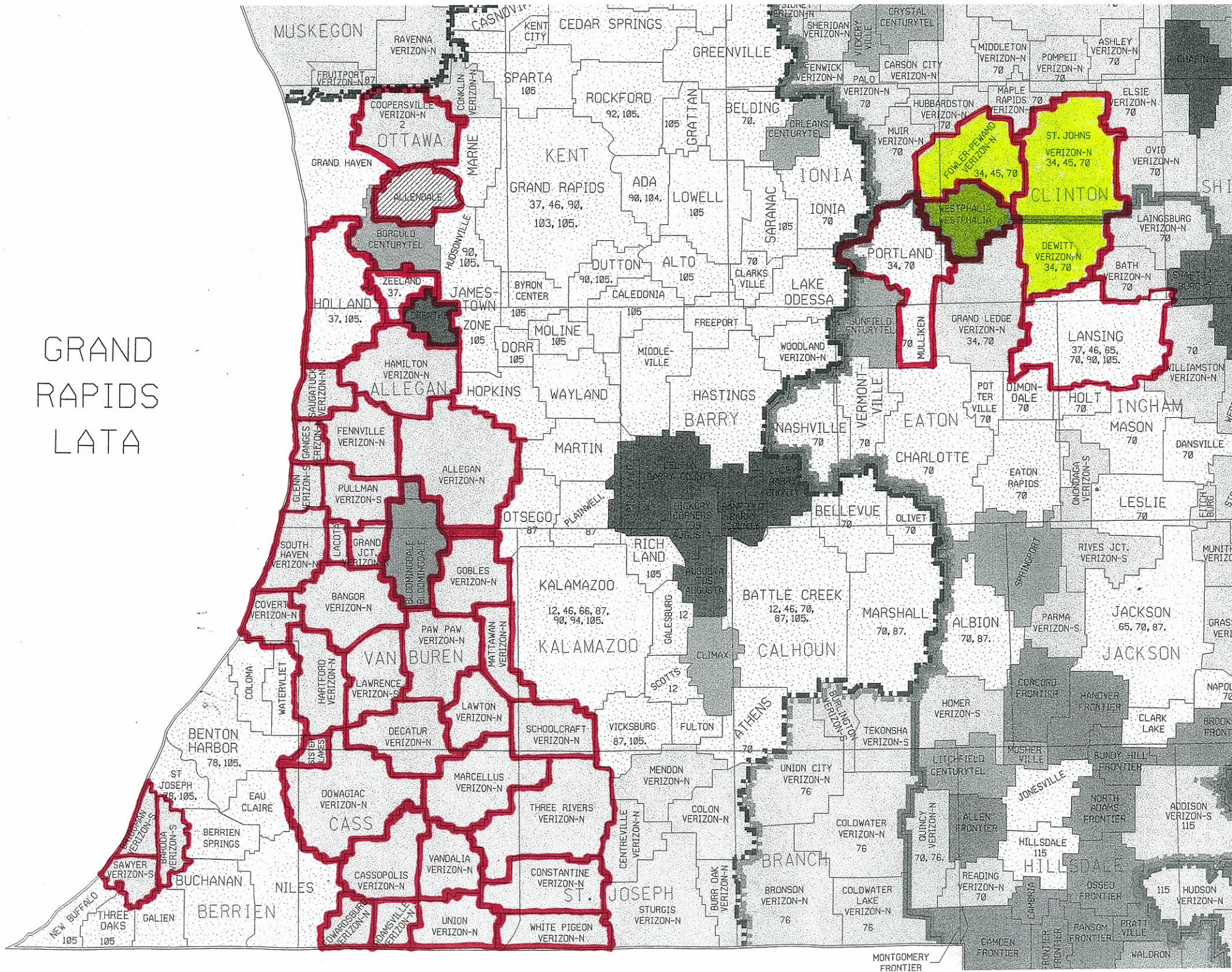

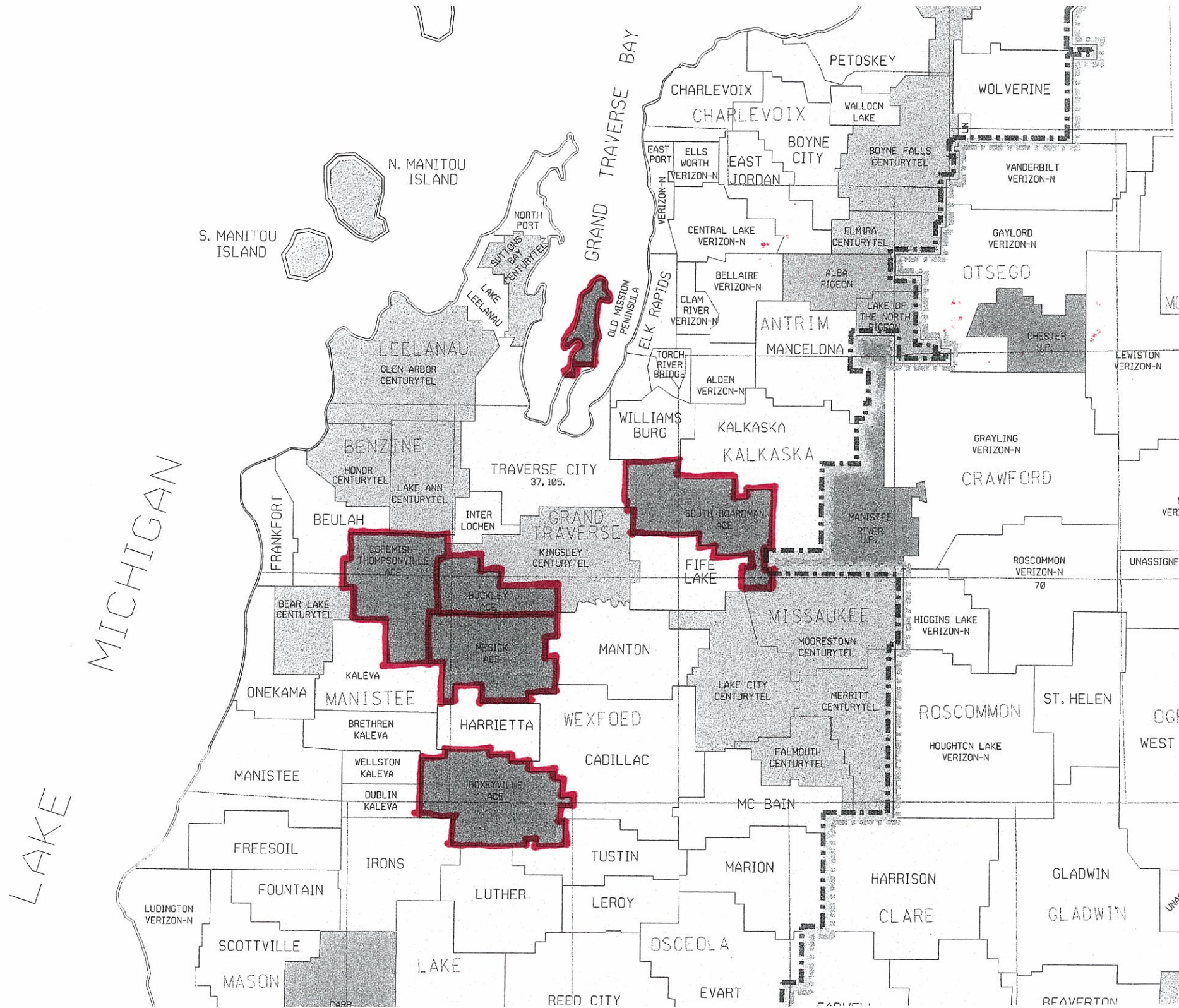
