Dear Ms. Dortch,

On April 19, 2011, West Corporation ("West") and Smoothstone IP Communications Corporation ("Smoothstone" and, together with West, the "Parties") filed the above-referenced joint domestic and international application for consent to a transfer of Smoothstone to West.¹ Pursuant to discussions with Staff, the Parties provide additional information and clarification with respect to the transaction:

1. Smoothstone provides service in forty-two states and the District of Columbia. An updated list of these jurisdictions is appended.
2. The Parties confirm that all of the Quadrangle and Thomas H Lee fund entities identified in the previous supplemental filing, including the members of the respective investment committees, hold U.S. citizenship.
3. Following consummation of the proposed transaction, Smoothstone will be a direct, wholly-owned subsidiary of West Corporation.

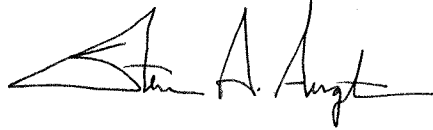
