This letter constitutes a supplement to the application of United Communications Holdings, LLC and United Telephone Company for the transfer of control of the domestic Section 214 authorization held by United Telephone Company. The application was filed with the Federal Communications Commission ("FCC") on June 24, 2011, and this supplemental filing is being made in response to a request from Ms. Jodie May, of the FCC's Competition Policy Division, Wireline Competition Bureau, for the following additional information in WC Docket No. 11-107.

MSouth Equity Partners GP, LLC and MSouth Equity Partners, LLC are both Delaware limited liability companies.

UTC Acquisition Company, Inc. is a Tennessee corporation and a wholly-owned subsidiary of United Communications Holdings, LLC. United Communications Holdings, LLC will acquire 100% of the issued and outstanding equity interests of United Telephone Company by way of a reverse subsidiary merger in which UTC Acquisition Company, Inc. will merge with and into United Telephone Company, with United Telephone Company surviving the merger as a wholly-owned subsidiary of United Communications Holdings, LLC.
