This letter provides further information regarding the application of UTC Long Distance, LLC (“UTC LD LLC”) for the transfer of control of the international and domestic Section 214 authorizations held by UTC LD, LLC to United Communications Holdings, LLC (“UCH LLC”). The application was filed electronically with the Federal Communications Commission (“FCC”)’s International Bureau on June 23, 2011, and with the Wireline Competition Bureau via U.S. Bank on June 24, 2011. This filing is being made via IBFS in response to a request from Ms. Sumita Mukhoty, Senior Attorney, Policy Division, International Bureau, pursuant to 47 C.F.R. § 63.51, for the following additional information in ITC-T/C-20110623-00175 (UTC LD LLC/UCH LLC). As requested by Ms. Mukhoty, it is also being filed simultaneously with the Wireline Competition Bureau via ECFS in WC Docket No. 11-107.

In response to the Commission’s inquiry regarding the state of formation of MSouth Equity Partners, L.P., the applicant states that MSouth Equity Partners, L.P. is a limited partnership that was formed in the state of Delaware. MSouth Equity Partners, L.P. is controlled by its general partner, MSouth Equity Partners GP, LLC, a Delaware limited liability company. Both MSouth Equity Partners, L.P. and MSouth Equity Partners GP, LLC are headquartered in Atlanta, Georgia. 
