Amendment No. 3

With respect to the Agreement dated November 29, 2001 (Exhibit A), as amended by Amendment No. 1 executed in March 2007 (Exhibit B) and Amendment No. 2 executed in October 2008 (Exhibit C), by and among the DEPARTMENT OF JUSTICE ("DOJ"), the DEPARTMENT OF HOMELAND SECURITY ("DHS"), MOBSAT HOLDING NORWAY AS ("MHN"), VIZADA AS ("VA"), MOBSAT HOLDING US CORP. ("MH"), VIZADA, INC. ("VI"), MARLINK, INC. ("MI"), VIZADA SECURE SERVICES, INC. ("VSEC," now known as VIZADA FEDERAL SERVICES, INC. ("VFS")), VIZADA SERVICES HOLDING, INC. ("VSH"), and VIZADA SERVICES LLC ("VLLC") (MHN, VA, MH, VI, MI, VFS, VSH, and VLLC, collectively, "VIZADA"), this Amendment No. 3 to the Agreement is entered into by and among DOJ, DHS, FBI, EUROPEAN AERONAUTIC DEFENCE AND SPACE COMPANY EADS N.V. ("EADS N.V."), ASTRIUM HOLDING S.A.S. ("ASTRIUM"), and VIZADA (collectively, the "Parties"), and is effective as of the date of the last signature hereto ("Effective Date").

Whereas subsequent to the execution of Amendment No. 2 the name of VSEC has changed to VFS;

Whereas there has been a proposed change in the indirect ownership of MHN, VA, MH, VI, MI, VFS, VSH, and VLLC, in that ASTRIUM, a wholly owned subsidiary of EADS N.V., has agreed to acquire 100% of the stock of MHN's ultimate parent MOBSAT GROUP HOLDING S.À.R.L. ("MGH"), and with it 100% indirect ownership of Vizada;

Whereas the Parties desire to amend the Agreement to add EADS N.V. and ASTRIUM to the Agreement, to accurately refer to the Parties by new names as appropriate, to update the Government Parties to the Agreement, and to update Article 9.1 of the Agreement with appropriate contact information for notices relating to the Agreement;

Now, therefore, in consideration of the promises, terms and conditions of the Amendment No. 3, and for other consideration, receipt of which is hereby acknowledged, the Parties agree as follows:

- Section 1. This Amendment No. 3 is entered into pursuant to Section 9.7 of the Agreement.
- Section 2. As of the Effective Date, (i) all references to TELENOR SECURE SERVICES, INC. or VSEC are hereby amended to refer to VFS; and (ii) MH, VI, MI, VFS, VSH, and VLLC are collectively referred to as "VIZADA USA."
- **Section 3.** As of the Effective Date, the FBI is hereby removed as a Party to the Amended Agreement.
- Section 4. As of the Effective Date, EADS N.V. and ASTRIUM are hereby added as signatories and Parties to the Amended Agreement, with all the rights, benefits and obligations of the Parties to the Agreement, as amended.
