One World Telecom, LLC ("One World Telecom") (FRN: 0015327851), by its attorneys, hereby notifies the Commission of a pro forma transaction pursuant to Section 63.24(f) of the Commission's Rules. This transaction occurred in 2011 and notice regarding it has not been provided previously to the Commission.¹

Ownership of One World Telecom Prior to the Transaction

At the end of 2010, fifty (50) percent direct ownership of One World Telecom was held by Contact Communications, LLC ("Contact"), a Florida limited liability company. Contact was owned in equal fifty (50) percent shares by Laurent Lamothe and Patrice Baker, both citizens of Haiti.

The remaining fifty (50) percent direct interest in One World Telecom was held by Business Telecommunications Services, Inc. ("BTS"), a Florida corporation. BTS, in turn, was wholly-owned by BTS Group, Inc., a Delaware corporation. BTS Group, Inc. was owned in equal fifty (50) percent shares by Rafael Olloqui and Ricardo Olloqui, both citizens of Spain.

One World Telecom has filed a separate pro forma notification regarding a transaction which occurred in January 2010. See File No. ITC-T/C-20120301-00069.

The 2011 Transaction

Effective January 1, 2011, the ownership interest in One World Telecom held by Contact was transferred to a new intermediary entity, Telco Equipment & Support Services, Inc. ("TESS"). As with Contact, TESS is owned in equal shares by Laurent Lamothe and Patrice Baker. Consequently, this transaction effected only a pro forma change to the ownership of One World Telecom. Following this transaction, ultimate indirect ownership of One World Telecom continues to be held by the same four individuals: Laurent Lamothe (25%), Patrice Baker (25%), Rafael Olloqui (25%), and Ricardo Olloqui (25%).

Diagrams of the ownership structure of One World Telecom prior to and following consummation of the transaction are provided in **Exhibit A**.

In accordance with Section 63.24(f)(2) of the Commission's Rules, One World Telecom provide the information requested in paragraphs (a) through (d) and (h) of Section 63.18 of the Commission's Rules.




