Most important, the license holder (Airtel USA Inc.) would still remain a US carrier after the transfer of control and it is in the hands of individuals known to the Commission.

Applicants do not meet any of the conditions of § 63.12 (c) that would justify the Applicants being denied streamlined processing of the transfer of control application within the 14 day time period.
