* Under the existing stockholders' agreement, AC Acquisition I LLC, AC Acquisition II LLC and their affiliates (collectively, "Ripplewood") appoint four out of nine members of the board of directors of Gogo Inc. (the "Company"), which is the direct parent of the Transferee. The stockholders' agreement also gives a Ripplewood entity certain special rights, including the right to consult with the Company in advance of significant decisions, including changes in management personnel, changes in employee compensation, introduction of new products, acquisitions or disposition of plant, equipment and licenses, and R&D programs. Ripplewood

also serves as the designated contact for the Company's primary FCC license. For these reasons, the Company considers Ripplewood to meet the Commission's standard for exercising *de facto* control.

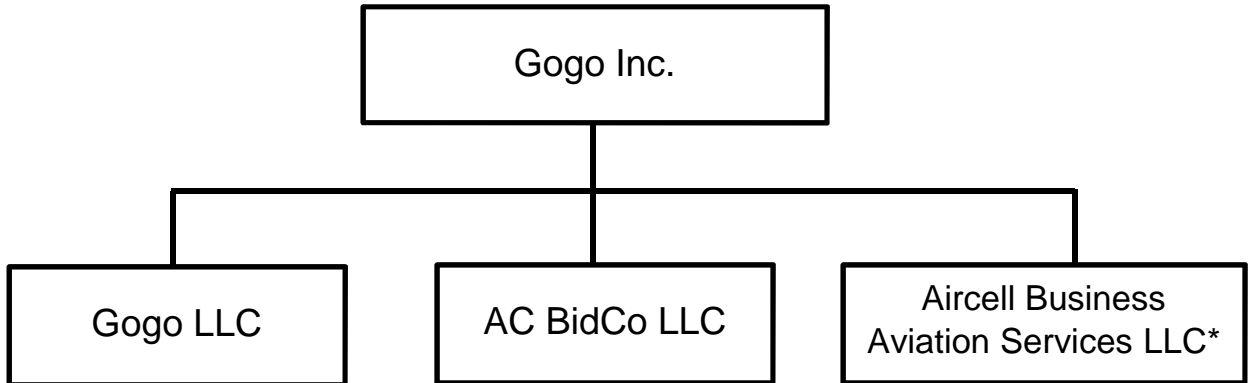
† Oakleigh Thorne holds an indirect interest in the Transferee through control, as determined by the FCC's rules, of more than 20 different entities, each of which individually holds less than a 10% interest in the Company. Mr. Thorne appoints three members of the board of directors. The Company regularly consults with Mr. Thorne in advance of making significant business decisions, as it does with Ripplewood.

No other entity or individual holds a 10% or greater voting or equity interest in the Transferee.

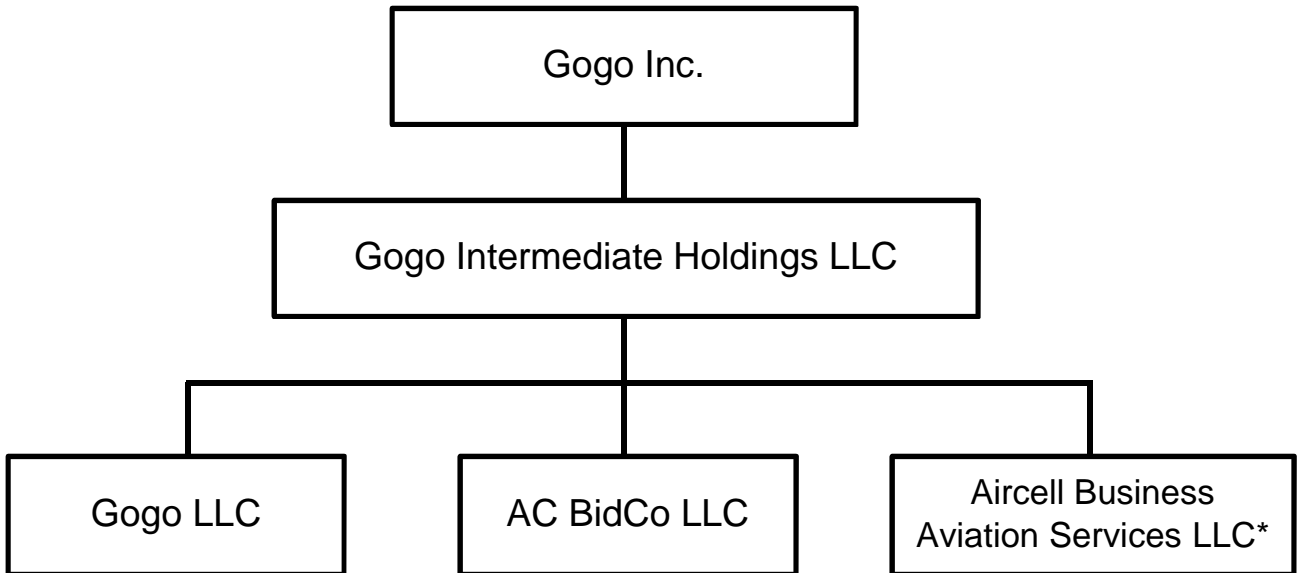
Answer to Question 13

The membership interests in Aircell Business Aviation Services LLC (the Section 214 holder) have been transferred from Gogo Inc. to Gogo Intermediate Holdings LLC, which is a direct, wholly-owned subsidiary of Gogo Inc. Therefore, this transaction is purely *pro forma* in nature. The corporate structure chart below illustrates the prior and current structures.
