Please review the following applications and advise us whether you have any national security, law enforcement, foreign policy or trade concerns by **Noon October 10, 2012**, because we are prepared to take action on these applications. **Electronic filed (e-file) applications are able to be viewed by accessing www.fcc.gov/ibfs and searching by the file number.**

ITC-214-20120910-00222 (e-file)
HARP TELECOM's application for authority to provide facilities-based and resale services between the United States and permissible international points. Applicant is 100% owned by a citizen of **Honduras**.

ITC-214-20120913-00230 (e-file)
Marcatel Telecommunications, LLC's application for authority to provide resale service between the United States and permissible international points. Telecom Overseas C.V. (TOCV), a limited partnership organized under the laws of **Netherland**, indirectly wholly owns the applicant. A citizen of **Mexico** owns more than 99% interest in TOCV.

ITC-T/C-20120919-00231 (e-file)
Application to update the ownership of Next Communications, Inc., holder of international section 214 authorization ITC-214-19990107-00014. Through a series of un-authorized changes in the ownership, Next Communications is now 37% owned by a citizen of **Turkey**.

ITC-T/C-20120906-00216 (e-file)
Application for consent to the transfer of control of Sumo Technologies, LLC's international section 214 authorization, ITC-214-20080612-00266. Mr. Enrique Baiz, a U.S. citizen, who presently holds 70% interest in the Licensee will transfer a total of 25% to Caral Investment Corp. (CARAL), ATHENIAN Venture Partners III L.P. (ATHENIAN), and Berwind LLC (BERWIND). The consummation of this transaction will increase CARAL's equity stake in the Licensee from 9.5% to 19.5%, both ATHENIAN and BERWIND's equity stake in the Licensee will be 7.7% each.

CARAL is a U.S. corporation, equally owned by three **Colombian** citizens. The authorization, ITC-214-20080612-00266 was granted on 02/03/2009 (DA 09-228, rel 02/12/09) with Team Telecom's consent (Richard Sofield's email of Feb. 3, 2009).

Next Communications, Inc. seeks Special Temporary Authority to continue operating international section 214 authorization ITC-214-19990107-00014 pending approval of the underlying application ITC-T/C-20120919-00231.
