4. Answer to Question 13 (Narrative of Proposed Transfer of Control)

Pursuant to a planned reorganization of Opextel, LLC (“Opextel”), 123.COM.VE C.A. (“123.COM.VE”) and NGS Telecom Holding LLLC (“NGS”) completed an intra-corporate reorganization on January 17, 2013. This transaction is a transfer of control pursuant to Section 63.24(c) of the Commission’s rules because it involves a transaction in which the authorization remains held by the same entity, but there is a change in the entity that controls the authorization holder. Further, this transfer of control is *pro forma* because both 123.COM.VE and NGS are wholly owned by Oceania Management and there is no change in the ultimate control of Opextel, as set forth in Section 63.24(d) of the Commission’s rules. *See* 47 C.F.R. § 63.24(d), Note 2.
