Pursuant to 47 C.F.R. §63.24(e)(4), this notice is to inform the Commission that, on December 31, 2013, the consummation occurred of the transfer of control of KeyArt Comm., Inc. (“KACI”) from Keystone-Arthur Telephone Company (“KATC”) to Glenwood Telephone Membership Corporation (“Glenwood”) as approved by the Commission on December 6, 2013 as noted in the Commission’s Public Notice, Report No. TEL-01645, DA No. 13-2355, released December 12, 2013 at 5. KeyArt Comm., Inc.’s international Section 214 authority was granted under File No. ITC-214-19970402-00188 and the transfer of control approved under File No. ITC-T/C-20131105-00292.
