Dear Sir or Madam:

On May 14, 2014, G3 Telecom USA Inc. (G3 Telecom USA) and Telehop Communications Inc. (Telehop) (together, Applicants) filed an application to transfer control of G3 Telecom USA to Telehop. Pursuant to the terms of the proposed transaction, G3 Telecom USA will be a direct, wholly-owned subsidiary of Telehop.

G3 Telecom USA offers international services under ITC-214-201110311-000063, offers resold interstate telecommunications services throughout the U.S., and offers resold intrastate telecommunications services in California, Georgia, Illinois, Michigan, Nevada, New Jersey, New York, Ohio, Texas, and Virginia. Telehop, a publicly-held corporation organized under the laws of **Ontario, Canada**, provides resold long distance services and interconnected Voice over Internet Protocol services within Canada.

Applicants state that the following individuals, all **Canadian citizens**, own at least 10 percent of the equity of Telehop: Rajan Arora (24.79 percent), James Estill (17 percent), and Mignonne Spiegelman (13 percent). Applicants state that neither Telehop nor its subsidiaries provide telecommunications services in the U.S.
