Answer to Question 11:

On August 1, 2014, CWW became the owner of 100% of the membership interests in Clear Stream. The following entities, directly or indirectly, own at least ten percent of the equity of Transferee as determined by successive multiplication in the manner specified in the note to Section 63.18(h) of the rules:

- 1. Skyline Telephone Membership Corporation ("Skyline") is a North Carolina corporation whose address is PO Box 759, West Jefferson, NC 28694-0759. Skyline owns a 47% stock interest in CWW. Skyline is an incumbent local exchange carrier that is organized as a cooperative in which subscribers are the company owners. No subscriber/owner has as much as a 1% ownership or voting interest in Skyline.
- 2. Surry Telephone Membership Corporation ("Surry") is a North Carolina corporation whose address is PO Box 385, Dobson, NC 27017-0385. Surry owns a 33.3% stock interest in CWW. Surry is an incumbent local exchange carrier that is organized as a cooperative in which subscribers are the company owners. No subscriber/owner has as much as a 1% ownership or voting interest in Surry.
- 3. Wilkes Telephone Membership Corporation ("Wilkes") is a North Carolina corporation whose address is 1400 River Street, Wilkesboro, NC 28697-2108. Wilkes owns a 19.7% stock interest in CWW. Wilkes is an incumbent local exchange carrier that is organized as a cooperative in which subscribers are the company owners. No subscriber/owner has as much as a 1% ownership or voting interest in Wilkes.

There are no interlocking directorates with a foreign carrier.

Answer to Question 13:

On August 1, 2014, wholly owned subsidiaries of CWW's only stockholders transferred their membership interests in Clear Stream to CWW. As a result, CWW became the sole owner of Clear Stream membership interests. Prior to that date, as the Commission's records indicate, Clear Stream was 10% owned by CWW and 30% owned by each of three wholly owned subsidiaries of the only three stockholders of CWW. CWW is shown as the "Transferor" and "Transferee" of control on the accompanying form because CWW is controlled by the same three companies that now control Clear Stream, through their ownership of CWW.

There has been no substantial change in the control of Clear Stream as a result of the ownership change.

Slayton S. Stewart continues to serve as the Managing Manager of Clear Stream and as the Chief Executive Officer of CWW.
