Under the proposed Transaction, Transferee will acquire 100 percent of the equity interests of NTI Talk. The transfer of control of NTI Talk will involve no disruption, impairment, or other changes in the entity providing service to customers, the facilities used to provide such services, or the rates, terms and conditions of such services. The contact points for customers and Commission inquiries will remain the same after the transfer of control. All existing customer service numbers/operations, contracts and procedures of NTI Talk will remain in place after the Transaction. Although the Transaction will result in a change in the control of NTI Talk, no assignment of authorizations, assets or customers will occur. NTI Talk will continue to provide service to

customers pursuant to NTI Talk authorizations under the same rate, terms and conditions. Accordingly, this Transaction will be transparent to the customer of NTI Talk.

**Answer to Question 20**

This Application qualifies for streamlined processing pursuant to Section 63.12 because the Applicants are not affiliated with any foreign carriers; are not affiliated with any dominant U.S. carriers whose international switched or private line services the Applicants seek authority to resell; and do not seek authority to provide switched basic services over private lines to a country for which the Commission has not previously authorized the provision of switched services over private lines. Accordingly, this Application should be granted, pursuant to Section 63.12(a), 14 days after the date of public notice listing this Application as accepted for filing.
