### **Answer to Question 13**

### Means by which transfer of control will take place

Currently, Ben Lomand Rural Telephone Cooperative, Inc. (Ben Lomand) owns fifty percent of the stock of Synergy and WK&T owns the other fifty percent with Synergy being controlled by WK&T's Board of Directors. Pursuant to a stock purchase agreement executed between Ben Lomand and WK&T, WK&T will acquire the 50% stock ownership of Ben Lomand, thereby becoming the sole shareholder of Synergy and the indirect holder of control of the Ardmore Section 214 authority.

Ardmore Telephone Company, the holder of the Section 214 authority, will remain a wholly-owned subsidiary of Synergy and will continue to operate under its Section 214 authority.

## **Answer to Question 20**

This application for transfer of control of international Section 214 authorization qualifies for streamlined processing pursuant to Section 63.12(c). The Transferee is not a foreign carrier and is not affiliated with any foreign carriers. The Transferee is not affiliated with a dominant U.S. carrier whose international switched or private line services the applicant seeks authority to resell.
