SOFTBANK Telecom America Corp. ("SOFTBANK Telecom America"), at the request of the FCC staff, hereby supplements the above-referenced notification of *pro forma* transfer of control to provide additional information related to SOFTBANK Telecom America's ownership history.

The above-referenced notification serves to inform that Commission of the *pro forma* transfer of control of SOFTBANK Telecom America from SOFTBANK Telecom Corp. to SOFTBANK Mobile Corp., both Japanese entities.

On March 5, 2007, notification was submitted to inform the Commission of the *pro forma* transfer of control of Japan Telecom America, Inc. (subsequently renamed as SOFTBANK Telecom America Corp.) to SOFTBANK Telecom Corp. (See File No. ITC-T/C-20070305-00094.)

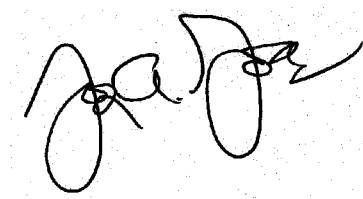
On July 28, 2004, notification was submitted to inform the Commission of the *pro forma* transfer of control of Japan Telecom America, Inc. from Japan Telecom Co., Ltd.,

to its direct parent, Japan Telecom Holdings L.P. (*See* File No. ITC-T/C-20040728-00325.)

On July 6, 2004, an application was submitted seeking consent to the transfer of control of Japan Telecom America, Inc. (itself a wholly-owned subsidiary of Japan Telecom Co., Ltd.) from Ripplewood Investments L.L.C. to SOFTBANK Corp. (*See* File No. ITC-T/C-20040706-00263.)
