Crestview, L.L.C. ("Crestview"), through its undersigned counsel, hereby supplements the above-referenced Application.

On March 17, 2017, pursuant to the request of FCC staff, the applicants submitted a Supplement to the above-referenced Application stating that Crestview had

no affiliate that provided telecom services (the “Supplement”). The FCC subsequently granted the Application on March 22 and March 30, 2017.

Following the grant of the Application, Crestview became aware that, in filing the Supplement, it had inadvertently overlooked an attributable investment in a U.K.-based company, Interoute Communications Holdings SA (“Interoute”), that is authorized to provide telecommunications service in the United States. At the time we filed the Supplement we did not focus on Interoute’s operations because it is based in Europe and operates principally in Europe. Upon further review, however, we became aware that it has subsidiaries with FCC licenses. Accordingly, Crestview hereby further supplements the record to inform the FCC of its affiliation with Interoute.

Crestview Partners III, L.P. (the same fund that indirectly owns the interest in WideOpen West that is the subject of the Application) owns a 15% indirect interest in Interoute, which is headquartered in London. Crestview has one of five board seats on the Interoute board of directors. Interoute is an integrated network and enterprise services company that owns and operates an extensive fiber network and cloud services platform across Europe. Interoute also has subsidiaries that hold international Section 214 authority to offer global facilities-based and resale services, and a U.S. subsidiary, Interoute USA, Inc., that, according to the FCC’s Form 499 Filer database, provides private services in the U.S. Although a private carrier would not be deemed to have domestic Section 214 authority, we are disclosing this affiliation out of an abundance of caution. Regardless, neither Interoute nor any of its subsidiaries compete with WideOpen West in any geographic areas.
