**STREAMLINED APPLICATION TO COMPLETE A TRANSFER OF CONTROL OF  
AN AUTHORIZED INTERNATIONAL SECTION 214 CARRIER**

Tello Communication, LLC (“Tello Communication”) and Abdul Tawab Molvi (together with Tello Communication, “Transferors”) pursuant to Section 214 of the Communications Act of 1934,<sup>1</sup> as amended, and Section 63.24 of the Commission’s Rules,<sup>2</sup> respectfully request authority for the transfer of control of Tello Communication, and, therefore, indirect control of Tello, LLC (“Tello”), from Mr. Molvi to Mr. Florin Miron, with ownership divided among Mr. Movli, Mr. Miron, Mr. Daniel Faur and Ms. Silvana Tatu (“the Transaction”) as described herein.

Although the Transaction will result in a change in the ultimate ownership of Tello, no assignment of licenses, assets, or customers will occur as a consequence of the proposed transaction. Tello will continue to provide service to its existing customers under the same rates, terms, and conditions. Accordingly, the Transaction will be transparent to customers of Tello,

LLC. As explained herein, this application qualifies for streamlined processing pursuant to Section 63.12<sup>3</sup> of the Commission's Rules.

**I. Request for Streamlined Processing**

The Applicants respectfully request streamlined treatment of this Application pursuant to Section 63.12 of the Commission's Rules, 47 C.F.R. § 63.12.

This Application is eligible for streamlined processing pursuant to Section 63.12(a)-(b) of the Commission's Rules, 47 C.F.R. § 63.12(a)-(b). In particular, Section 63.12(c)(1) is inapplicable because neither of the Applicants is a foreign carrier, or affiliated with any foreign carrier, and none of the scenarios outlined in Section 63.12(c) of the Commission's Rules 47 C.F.R. § 63.12(c), applies.

In support of this Application, Applicants provide the following information.

**II. Description of the Applicants:**

**A. Transferors**

**1. Tello Communication, LLC**

Tello Communication, LLC is a Georgia limited liability company with its principal business offices located at 4780 Ashford Dunwoody Rd., Suite A236, Atlanta, GA 30338. Tello Communication is a holding company, which owns Tello, LLC. Tello, LLC is a Georgia limited liability company with principal business offices located at 4780 Ashford Dunwoody Rd., Suite A236, Atlanta, Georgia, 30338. Tello provides prepaid wireless telecommunications service in all 50 states, and the District of Columbia. Tello's services include domestic and international calling, text messaging and wireless data (Internet access). Tello also sells handsets (phones). Tello holds international Section 214 authority granted in ITC-214-20170714-00127.

## **2. Abdul Tawab Molvi**

Mr. Molvi is a U.S. citizen and the 100% owner of Tello Communication, LLC. Mr. Molvi's principal address is 4780 Ashford Dunwoody Rd., Suite A236, Atlanta, Georgia 30338.

### **B. Transferees**

#### **1. Florin Miron**

Mr. Miron is a Romanian citizen. Mr. Miron's principal address is Str. Alexandru Xenopol, NR 13, Apt 5, Sibiu, 550159 Romania.

#### **2. Daniel Faur**

Mr. Faur is a Romanian citizen. Mr. Faur's principal address is Calea Cisnadiiei 15, SC. A, AP M2, Sibiu, 550376 Romania.

#### **3. Silvana Tatu**

Ms. Tatu is a Romanian citizen. Ms. Tatu's principal address is 5 Suru Street, Sibiu, 550317 Romania.

### **III. Description of the Transaction**

By this Application, the Applicants seek authority to transfer control of Tello Communication and, therefore, indirect control of Tello, from Mr. Molvi to Florin Miron, with ownership as follows: Florin Miron (92.5%); Daniel Faur (2.5%); Abdul Tawab Molvi (2.5%); Silvana Tatu (2.5%).

Following the Transaction, Tello Communication will continue to operate as a holding company, with ownership of Tello. Tello's customers will remain customers of Tello and will continue to receive services under the same rates, terms and conditions. As a result, the Transaction will be virtually transparent to Tello's customers. The only change resulting from the

Transaction will be the indirect change in control of Tello through the change in ownership and control of Tello Communication.

**IV. Public Interest Statement**

The proposed Transaction will serve the public interest by enabling Tello to expand its operations and compete more effectively in the telecommunications marketplace.

Given the increasingly competitive nature of the telecommunications market, Applicants are seeking to complete the proposed Transaction as soon as possible to ensure that customers can obtain rapidly the benefits of the proposed Transaction. Accordingly, Applicants respectfully request that the Commission process, consider and approve this Application as expeditiously as possible.

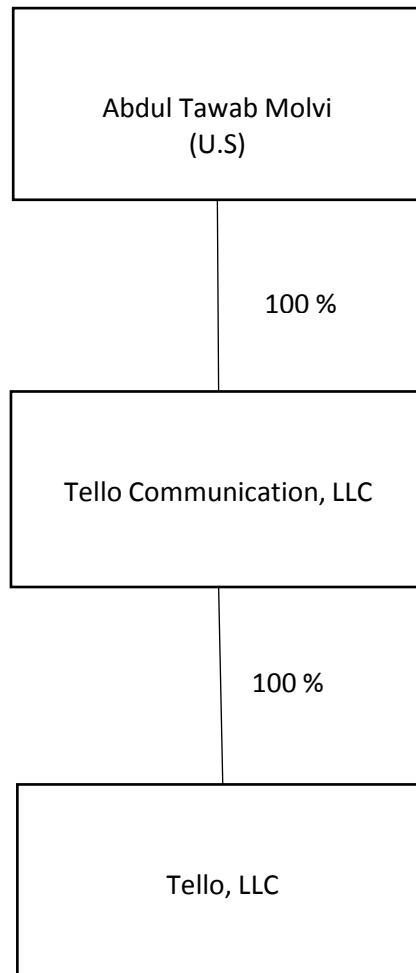
