Pursuant to the Transfer, TD Holdings merged with Telefonica Digital España SLU ("TD Spain"), with TD Spain surviving the merger. TD Spain is wholly owned by Telefonica S.A. The Transfer was completed on September 14, 2017. TDI certifies that the Transfer was *pro forma* and that, together with all previous *pro forma* transactions, the Transfer did not result in a change in the actual controlling party of TDI.


