Pursuant to 47 C.F.R. §63.24(e)(4), this notice is to inform the Commission that, on February 28, 2018, consummation occurred of the transfer of control of Lackawaxen Telecommunications Services, Inc. ("LTS"), Lackawaxen Long Distance Company ("LLDC") and LCI Communications, Inc. to Laurel Highland Total Communications, Inc.
