**Notification of *Pro Forma* Transfer of Control**

Pursuant to Section 214 of the Communications Act of 1934, as amended, (“the Act”), 47 U.S.C. § 214 and Section 63.24(f) of the Commission’s rules, 47 C.F.R. § 63.24(f), Central Louisiana License Co., LLC (“Central Louisiana License”) hereby notifies the Commission of the *pro forma* transfer of control as a result of an internal reorganization. As more fully explained in response to Question 13 below, the ultimate ownership or control of the international Section 214 authorization at issue has not changed, and is, therefore, *pro forma* in nature. The *pro forma* transfer of control occurred on December 27, 2017.<sup>1</sup>

**Answer to Question 13:**

Prior to consummation of the *pro forma* subject to this notification, Alta's 58.70% membership interest in Central Louisiana License was directly held in Central Louisiana Holdco, Inc.,<sup>2</sup> which in turn owns 58.70 percent of Central Louisiana Holdco, LLC, which in turn, owns 100 percent of Central Louisiana Cellular, LLC, which in turn, owns a 100 percent of Central Louisiana License.

On December 27, 2017, Central Louisiana Holdco, Inc. was dissolved. Nonetheless, Alta continues to hold a 58.70% membership interest in Central Louisiana License. Its interest is now

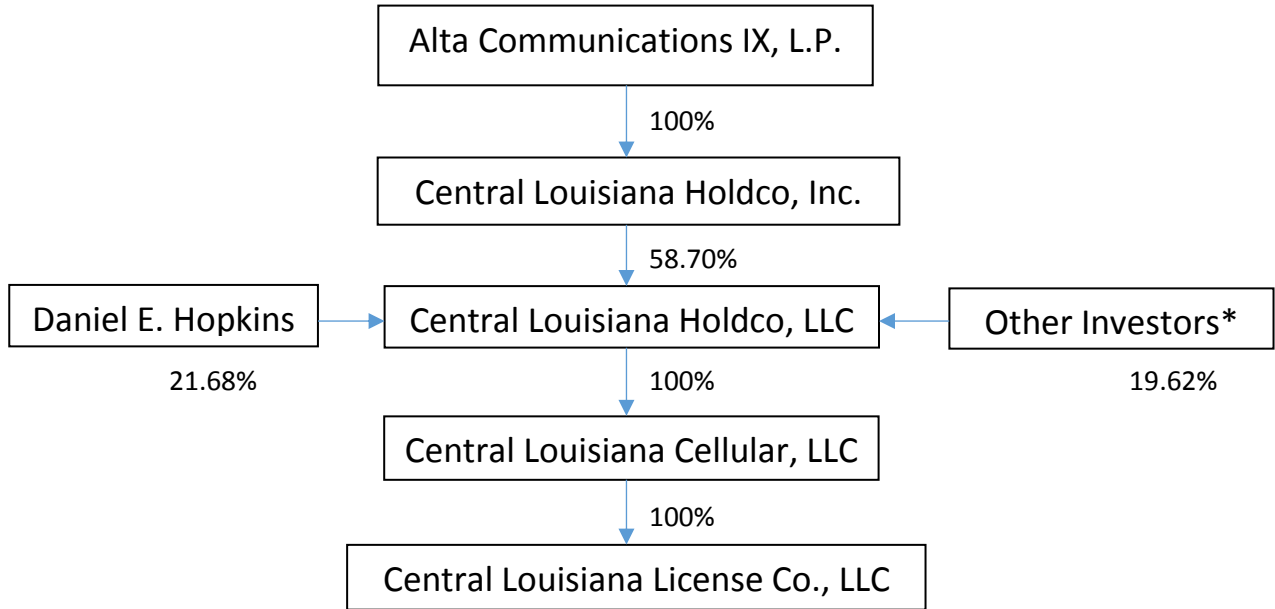
directly held in Central Louisiana Holdco, LLC,<sup>3</sup> which in turn, owns 100 percent of Central Louisiana Cellular, LLC, which in turn, owns a 100 percent of Central Louisiana License. Therefore, no substantive change in control occurred as a result of the dissolution of Central Louisiana Holdco, Inc.

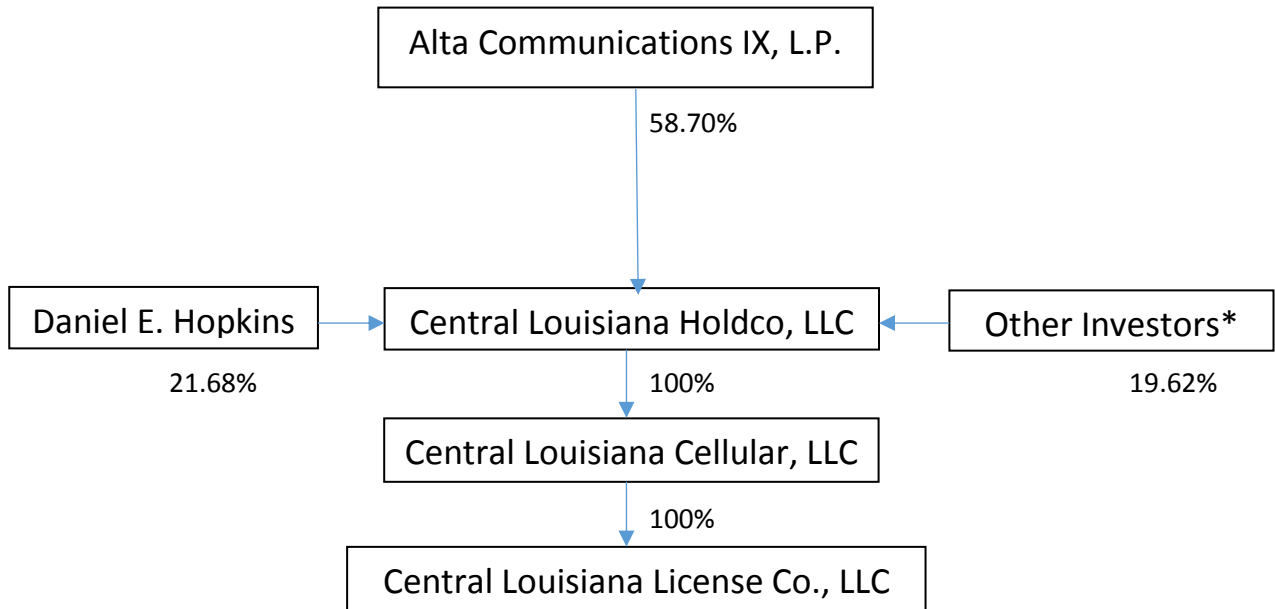
