Answer to Question 13:

Alta currently holds 58.70% of the membership interests in Central Louisiana License. Its interest is directly held in Central Louisiana Holdco, LLC, ² which in turn, own 100 percent of Central Louisiana Cellular, LLC, which in turn, owns a 100 percent of Central Louisiana License.

Upon consummation of the transaction, Alta's interest³ will be distributed to Mssrs. Foxman and Hopkins, whose interest will be directly held in Anacoco Capital Partners, LLC. Anacoco Capital Partners, LLC will own 84 percent of Central Louisiana Holdco, LLC, which in turn, owns 100 percent of Central Louisiana Cellular, LLC, which in turn, owns 100 percent of Central Louisiana License. In addition, both Mssrs. Foxman and Hopkins will become the Managers of Central Louisiana License, a manager-managed Delaware limited liability company. No other individual or entity will hold a 10 percent or greater direct or indirect interest in Central Louisiana License.


Section 63.18 (p): Request for streamlined processing (Answer to Question 20):


