Answer to Question 13

ATN International, Inc. (“ATN”), Choice’s ultimate parent company, underwent an internal corporate reorganization on January 2, 2018. As part of the reorganization, Choice, which was directly owned and controlled by ATN International, Inc. (“ATN”), became a wholly-owned, direct subsidiary of a different ATN subsidiary, Vitelcom Cellular, Inc. d/b/a Viya Wireless and Viya Mobility. Inasmuch as ATN remains in ultimate control of Choice, the reorganization was *pro forma* in nature. The following chart illustrates the *pro forma* reorganization.
