**Answer to Question 10**, providing information regarding previous Section 214 authorizations pursuant to Section 63.18(d):

RiverStreet's parent, Wilkes Telephone Membership Corporation ("WTMC"), owns 100% of the equity interests of Wilkes Communications, Inc. ("WCI"), which holds international Section 214 authorization pursuant to IB File No. ITC-214-20110826-00284. WCI is also authorized to provide interstate service by virtue of blanket domestic Section 214 authority. 47 C.F.R. § 63.01.<sup>1</sup>

**Answer to Question 11**, providing ownership information pursuant to Section 63.18(h):

### **Transferor Ownership**

Mr. Daniel M. Bennett holds one hundred percent (100%) of the outstanding shares of Ellerbe Telephone Company ("Ellerbe"), a North Carolina corporation, which, in turn, owns one hundred percent (100%) of the membership interests in the authorization holder, ETCOM, LLC, a North Carolina limited liability company.

### **Transferee Ownership**

RiverStreet Management Services, LLC ("RiverStreet"), a North Carolina limited liability company, is a wholly-owned subsidiary of Wilkes Telephone Membership Corporation ("WTMC"), a North Carolina cooperative association. WTMC is owned by its member/subscribers; no single member/subscriber owns or controls more than 5% of WTMC's equity.

**Answer to Question 13**, providing information regarding the proposed means of transfer:

The Applicants propose the consummation of a transaction whereby RiverStreet will purchase 100% of the shares of Ellerbe. Ellerbe and its wholly-owned subsidiary, ETCOM, will maintain their separate existence.

("Consolidated") filed a Joint Application for transfer of control of the domestic and international Section 214 authorizations held by Peoples Mutual Telephone Company and Peoples Mutual Long Distance Company ("PMLDC") (together, the "Peoples Companies") from Consolidated to RiverStreet, including the International Section 214 authorization held by PMLDC (File No. ITC-214-20001207-00717) and the domestic interstate blanket authorizations held by the Peoples Companies by virtue of Section 63.01 of the Commission's Rules. *See Domestic Section 214 Application Filed for the Transfer of Control of Peoples Mutual Telephone Company and Peoples Mutual Long Distance Company to RiverStreet Management Services, LLC*, Non-Streamlined Pleading Cycle Established, WC Docket No. 17-365, DA 18-48 (Jan. 16, 2018). That application is currently pending.
