To clarify the Supplemental Filing submitted in this proceeding May 8, 2018, Transferee Wabash Independent Networks, Inc. ("WIN"), a wholly-owned subsidiary of Wabash Telephone Cooperative, Inc. ("WTCTI"), provides the following information regarding the Application filed to seek approval of its proposed purchase of the stock of Respond Communications, Inc., ("Respond"), the one hundred percent (100%) owner of each of Montrose Mutual Telephone Company ("MMTC") and Montrose Mutual Long Distance, Inc. ("MMLD").

WIN reiterates and confirms that neither WIN nor WTCTI, nor any of their affiliates or subsidiaries, currently provides services to any territory that overlaps with the service territory of MMTC or MMLD except that it has (i) marketed its retail services within the MMTC/MMLD service territory, but does not currently have any customers or provide service there; and (ii) procured a special access circuit (one single dark fiber) from MMTC used to transport traffic to and from a single cell site in MMTC territory.

In further clarification of its May 8, 2018 submission, Transferee WIN reiterates and confirms that neither WTCTI nor WIN hold any interest in any telecommunications carrier other than those identified in the application and in its May 8, 2018 Supplemental Filing.
