The Estate of Jack Lee Barton, the Non-Exempt Marital Income Trust U/W Jack Lee Barton, Lintel, Inc. ("Lintel"), Hart Telephone Company ("HTC") and Hart Communications, Inc. ("HCI") (collectively the "Applicants"), by counsel, hereby files this supplement to the above-referenced joint domestic and international Section 214 transfer of control application electronically submitted on September 18, 2019. Along with the attached Declaration of James R. Daniel, Jr., this supplement provides the following information regarding Lintel and information regarding affiliated interests of the Non-Exempt Marital Income Trust U/W Jack Lee Barton (the "Transferee") and the other four (4) trusts as noted in the application (collectively, the "Trusts").

Lintel is a holding company and provides no domestic telecommunications services. In addition, the Transferee (including its trustees and beneficiaries) along with the trustees and beneficiaries of the remaining Trusts that will have less than a 10% interest in Lintel do not any additional affiliates that provide domestic telecommunications services other than CoastalNet Georgia, Inc as noted in footnote 5 to the above-referenced application. The Applicants do note that, in and around the area served by HTC, HCI re-sells HTC's DSL internet services. Hart Cable Company, a wholly-owned subsidiary of Lintel, provides cable modem internet services and provides cable television services in and around the area served by HTC.


