I am writing as counsel of record to T3 Communications, Inc., a Nevada corporation (“T3NV”), and Nexogy, Inc. (“Nexogy”). This letter responds on behalf of both companies to the follow-on inquiries of Commission staff in the above-captioned matter, received on Tuesday, January 7, 2020.

The following information is responsive to your requests:

1. T3NV, the transferee, and its owners do not have any other domestic telecommunications affiliates not identified in this proceeding.

2. Nexogy, the transferor, has an FCC-licensed affiliate that provides telecommunications services, although this entity is not a corporate affiliate in the same corporate family as Nexogy. LD Telecommunications, Inc., which holds ITC-214-19990827-00560, is wholly owned by LD Telecom, Inc. In turn, LD Telecom, Inc. is owned in large part by the same three principal shareholders that are the three principal shareholders of Nexogy. Specifically, the three principal shareholders of LD Telecom, Inc. are: Carlos Lahrssen, Jr. Revocable Trust (25.29%); Felipe Jose Lahrssen Revocable Trust (25.29%); and Juan Carlos Canto (20.32%). No other shareholder holds 10% or more of LD Telecom, Inc. LD Telecommunications, Inc. provides wholesale voice services to U.S. and international carriers.

3. All ownership interests in T3NV are U.S.-based.
