JOINT APPLICATION

I. INTRODUCTION

Pursuant to Section 214 of the Communications Act of 1934, as amended (the "Act"), 47 U.S.C. § 214, and Sections 63.01, 63.03, 63.04, 63.18, and 63.24 of the rules and regulations of the Federal Communications Commission ("FCC" or "Commission"), 47 C.F.R. §§ 63.01, 63.03, 63.04, 63.18 and 63.24, Fiona Harlan ("Mrs. Harlan" or "Transferor") as Trustee of the Harlan Family Trust dated August 21, 2018 (the "Trust") and Southwest Tennessee Electric Membership Corporation ("STEMC" or "Transferee" and collectively with the Transferor, the "Applicants") by this application ("Joint Application") request Commission consent for the transfer of control of the domestic and international Section 214 authority held by Aeneas Communications, LLC ("Aeneas" or "Aeneas Communications"), to STEMC through STEMC's acquisition of all of the membership interests in Aeneas pursuant to a Purchase Agreement dated

as of August 15, 2019 ("Agreement"). The transfer of all of the membership interests in Aeneas to STEMC pursuant to the Agreement is hereinafter referred to as the "Transaction."

In Section V of this Joint Application, the Applicants provide the information required by Sections 63.18 and 63.24 of the Commission's rules, 47 C.F.R. §§ 63.18 and 63.24, for the transfer of control of the international Section 214 authorization. As required by Section 63.04(b) of the Commission's rules, 47 C.F.R. § 63.04(b), Section VI of this Joint Application provides the additional information required for the transfer of control of the authorization used in the provision of domestic telecommunications services arising from the Transaction.

The Applicants respectfully request streamlined treatment of the Joint Application pursuant to Sections 63.03 and 63.12 of the Commission's rules, 47 C.F.R. §§ 63.03 and 63.12. The Transaction will not result in a change of the terms and conditions of service to current Aeneas customers, and raises no competitive issues. Expeditious approval of the Transaction will serve the public interest by allowing for increased operational efficiencies and by allowing customers to continue to receive services without interruption.

II. DESCRIPTION OF THE APPLICANTS AND AUTHORIZATION HOLDER

a. Mrs. Harlan and the Trust

Fiona Harlan is a U.S. Citizen. Mrs. Harlan is the sole trustee of the Trust and the President of Aeneas. Mrs. Harlan also is the sole lifetime beneficiary of the Trust. Mrs. Harlan became sole trustee of the Trust and the President of Aeneas following the passing of her husband, Johnathan V. Harlan ("Mr. Harlan") in November of 2018. Mr. Harlan was the founder, President and Chief Executive Officer of Aeneas until he assigned his membership interests in Aeneas to the Trust, at which time Mrs. Harlan became President of Aeneas and Stephen Thorpe became CEO of Aeneas.

The Trust is a revocable living trust created and certified on August 21, 2018, under Tennessee law, TCA 35-15-1013. The Trust holds all of the membership interests in Aeneas.

b. STEMC

STEMC is a member-owned, nonprofit electric distribution cooperative with headquarters in Brownsville, Tennessee. STEMC provides electric services to portions of 11 counties in western Tennessee. STEMC does not provide telecommunications services.

c. Aeneas

Aeneas is a provider of communications services headquartered in Jackson, Tennessee. Aeneas is a competitive local exchange carrier registered in Tennessee and authorized to provide services throughout the state. Aeneas offers services through a combination of its own facilities and resale arrangements with other carriers, providing competitive local telecommunications, long distance telecommunications, high-speed Internet, and Voice over Internet Protocol services (collectively, the "Services") primarily in western Tennessee. Aeneas offers all Services in Bedford, Benton, Carroll, Cheatham, Chester, Coffee, Crockett, Davidson, Decatur, Dickson, Dyer, Fayette, Franklin, Gibson, Giles, Hardeman, Hardin, Haywood, Henderson, Henry, Hickman, Humphreys, Lake, Lauderdale, Lawrence, Lewis, Lincoln, Madison, Marshall, Maury, McNairy, Montgomery, Moore, Obion, Robertson, Rutherford, Shelby, Smith, Stewart, Sumner, Tipton, Trousdale, Weakley, Williamson, and Wilson counties, Tennessee.

III. DESCRIPTION OF THE TRANSACTION

Pursuant to the Agreement, STEMC will acquire all of the membership interests in Aeneas from the Trust. STEMC will then own 100% of the ownership of and membership interests in Aeneas. Post consummation, Aeneas will continue to exist and operate under the

same name, and the Transaction will not result in a change to the terms and conditions of service, including Lifeline service, pursuant to which to Aeneas provides service to its customers.

IV. PUBLIC INTEREST STATEMENT

Approval of the Transaction will serve the public interest, convenience, and necessity. A grant will permit the continued, uninterrupted provision of high-quality service to customers. The consummation of the Transaction and transfer of control of Aeneas will not result in an interruption, reduction, loss or impairment of services to any subscriber, and the Applicants are not aware of any harms to customers or to the market that will result from the consummation of the Transaction. Aeneas is a small telecommunications provider and will benefit from greater operational and administrative efficiencies as a result of the Transaction and the acquisition by STEMC. Under STEMC's ownership Aeneas will be able to improve and expand the provision of competitive services in Tennessee.

STEMC has a demonstrated history of advancing the deployment of technologies for member benefit, with each deployment increasing employee safety, lowering operating costs, and decreasing member interruptions. STEMC's next investment in technology is in the form of a Smart Grid Fiber Network. Approval of the Transaction will solidify the use of excess capacity on STEMC's Smart Grid Fiber Network to deploy retail broadband and VoIP services, as well as provide network engineering expertise for the Smart Grid Communications Network. Additionally, approval of the Transaction will allow Aeneas to expand services into largely unserved and underserved areas of STEMC's rural service area.

This Application qualifies for presumptive streamlined processing pursuant to Section 63.03(b)(1)(ii) because the Transferee, STEMC, is an electric utility that does not provide telecommunications services. This Application also is eligible for presumptive streamlined treatment pursuant to Section 63.03(b)(2)(i) of the Rules because (1) following consummation of the proposed Transaction, Transferee will have less than a 10 percent share of the interstate, interexchange market and will provide competitive telephone exchange services exclusively in areas served by a dominant local carrier not a party to the Transaction; and (2) none of the Applicants are regulated as dominant with respect to any service.

Concurrently herewith, the Mrs. Harlan and the Trust are submitting a request for Special Temporary Authority for Aeneas to continue to provide domestic telecommunication services under the control of the Trust.

The Trust and the estate of Mr. Harlan, concurrently herewith, also are submitting an application requesting approval of the prior transfer of control that resulted from Mr. Harlan's

assignment of all of his membership interests in Aeneas to the Trust on August 21, 2018 ("Trust Transfer Application").

Aeneas concurrently herewith also is submitting an application requesting approval of the subsequent involuntary transfer of control from Mr. Harlan, as a co-trustee of the Trust, to Mrs. Harlan as the remaining sole trustee of the Trust, upon Mr. Harlan's death on November 12, 2018 ("Involuntary Transfer Application").

The Applicants request that Commission consider and act on this Joint Application, the Trust Transfer Application, and the Involuntary Transfer Application concurrently, and expeditiously.¹

§ 63.04(a)(10) Statement Regarding Special Consideration.

The Applicants do not request special consideration because no party to the Transaction is facing imminent business failure.

§ 63.04(a)(11) Identification of Waiver Requests.

The Applicants will not seek a waiver in conjunction with the Transaction.

¹ No international applications are being filed in connection with the Trust Transfer Application or the Involuntary Transfer Application because Aeneas did not hold international Section 214 authority at the time of the assignment of the membership interests to the Trust or of Mr. Harlan's death. Aeneas subsequently obtained international Section 214 authority, the transfer of control of which is sought in this Joint Application.
