Dear Secretary Dortch:

On December 16, 2019, Lingo Communications, LLC, the Lingo Licensees, and Garrison LM LLC (collectively, "Applicants") filed a Joint Application seeking Commission approval to transfer indirect control of the Lingo Licensees to Garrison LM LLC ("Transferee"). The Applicants seek to supplement the Joint Application as set forth herein.

On December 18, 2019, the Applicants filed a supplement to correct errors contained in the Joint Application with respect to the FCC Registration Numbers ("FRNs") for certain Lingo Licensees. For the Commission's convenience, Applicants repeat those FRN corrections here, and make additional corrections to the ownership percentages for GG Telecom Investors, LLC ("GG Telecom"). The Joint Application should be amended to reflect the following:

- Lingo Telecom of the Great Lakes, LLC FRN: 0005072780
- Lingo Communications South, LLC FRN: 0005027420
- Lingo Telecom of the West, LLC FRN: 0008159725
- The ownership percentages for GG Telecom listed on page 2 and Exhibit B of the Joint Application should be Holcombe T. Green, Jr. (62.5%) and R. Kirby Godsey (37.5%).
